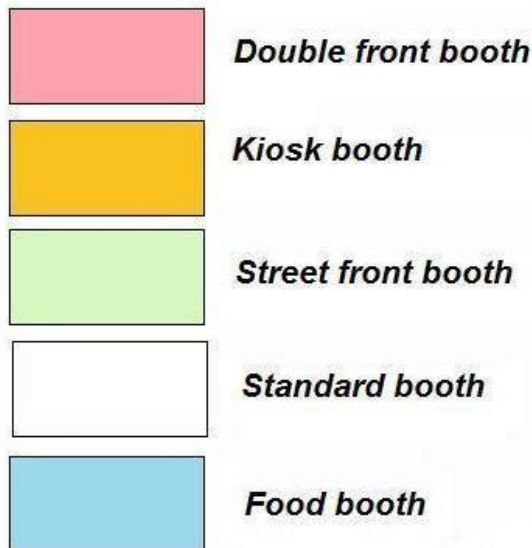

Entries received after April 1 will be charged a late entry fee of \$10.

Entries including non-digital photos in place of CD or emailed photos will be charged a \$10 processing fee.

Each application must be accompanied by a check, payable to the Saugatuck Douglas Art Club. We will refund the booth fee and the city license fee if you are not accepted. However there will be no other refunds for vendors who have applied, have paid, and have been accepted.

Please send one digital photo of your booth set-up, one digital photo of you making one of your pieces, and at least three close-ups showing your work. Close-ups should document each category you tell us you plan to sell. All photos will be juried to allow the Art Club to maintain the high quality of the show. Digital photographs may be submitted via email to artclub@saugatuckdouglasartclub.org, or on a CD (not a DVD) with your application. Only digital photos will be accepted, because of our jurying and auditing requirements.
