**FEE: \$120.** Each application must be accompanied by a check payable to the Saugatuck Douglas Art Club. It covers a booth fee of \$90, a \$10 city license fee, and a \$20 nonrefundable application fee. We will refund the booth fee and the city license fee if artist is not accepted. Please send one digital photo of your booth set-up, one digital photo of you making one of your pieces, and three close-ups showing your work. JPGs are preferred and extremely small photos are hard to jury. 9" x 6" is a common size our applicants supply. Photos of your work are considered for our poster and postcard for this year's fairs. All photos will be juried to allow the Art Club to maintain the quality of the fair. Late entry fees and fees for processing paper photos will be charged; consult the rules. Digital photographs may be submitted via email to [artclub@saugatuckdouglasartclub.org](mailto:artclub@saugatuckdouglasartclub.org), or on a CD with your application, however, the CD will not be returned unless appropriate postage is supplied.
